Job Title: Trainers / Assessors

Position Profile

Trainer / Assessors are required to plan, deliver, and review training and assessment to meet client needs and determined competency requirements, to the standard required by DTW Designs (Qld) Pty Ltd and external accreditation authorities. Trainer / Assessors are responsible and accountable for their own work, which is to be performed within DTW Designs (Qld) Pty Ltd's established routines, method and policy. The Trainer / Assessor is to train / assess all course participants in the skills as set by the standards of the industry skills council, DTW Designs (Qld) Pty Ltd, the client or other nominated body (by the company) by means of personal instruction and demonstration

Key Responsibilities

- Planning, initiating and delivering assessments, including recognition of prior learning to students
- Planning, initiating and delivering training from endorsed Training Packages on the scope of registration, in accordance with the Standards for NVR Registered Training Organisations and Australian Qualifications Framework (AQF)
- Pursuing professional development to ensure personal knowledge, skills and competencies relevant to their training and assessing duties are current and constantly advanced
- Implementing a continual improvement process regarding the training and assessment duties by acknowledging and acting on feedback from students and stakeholders
- Completing and maintaining all documentation related to training ensuring that records are complete, thorough and accurate, and that confidentiality is maintained
- Providing guidance and counselling to students, assisting in every way to ensure that training outcomes are met and that individuals succeed in their endeavours
- Maintaining a thorough and complete understanding of and ensure compliance with all policies and procedures, SNR and legal obligations related to the RTO and the services it delivers
- In consultation with the RTO Administrator, dealing with grievances and appeals in a prompt, fair and decisive manner
- Ensuring familiarity with the risk management plan and procedures
- Preparing and submitting reports in relation to training and assessment and risk management
- All trainers and assessors are to be TAE40110 Certificate IV in Training and Assessment qualified and have qualifications and industry experience relevant to the units of competency that they deliver and / or assess
- Where assessments are to be conducted by subject matter experts who do not have the appropriate qualification, they are to work in conjunction with a holder of the Certificate IV in Training and Assessment
- Where trainers do not have the appropriate qualifications, they are to be supervised by a holder of the Certificate IV in Training and Assessment

- All DTW Designs (Qld) Pty Ltd staff members are responsible for advising the Director of any conditions, which are adverse to the quality of the work being produced or adverse to the satisfactory operation of the Quality System

Organisational Relationships

- Reports directly to Training Coordinator who is accountable to Training Manager

- Industry qualifications to at least the level being trained and /or assessed.
- Professional Development in accordance with DTW Designs (Qld) Pty Ltd RTO Staff Policy
- Training/education qualifications to at least Certificate IV in Training and Assessment (TAE) or as amended by NSSC
